**Sub: Corporatization of Rail Coach Factory, Kapurthala**  
**Ref: Railway Board's letter No.ERB-I/2011/23/57 dated 28.12.2011**

It has been brought to our notice that the Railway Board vide their letter referred to above has constituted Committee to hold discussion with staff federations and to finalize terms of reference of the consultant to be appointed to assist the Ministry of Railways in the process of corporatization of RCF, Kapurthala.

This is highly objectionable. All India Railwaymen's Federation has always opposed any sort of corporatization in the Indian Railways, and on this particular issue, there had been lot of industrial unrest in the year 2006, and due to mass scale agitation by the employees of the Rail Coach Factory, Kapurthala and their families and opposition by the Federations, such proposal was withdrawn by the then MR with an assurance that such scheme would never be enforced.

We are surprised over short memory of the Railway Board and request you to withdraw such proposal, which may again lead to industrial unrest at Rail Coach Factory, Kapurthala and other parts of the Indian Railways.

Please treat the matter as most urgent.
