participants by allowing them Special Leave and Duty Pass.

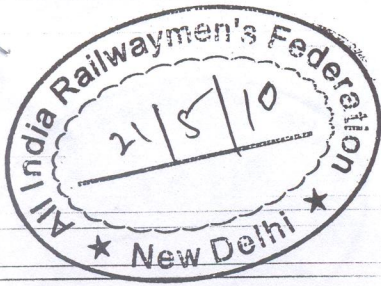
