Sub : Revised pay limits for entitlement of Passes/PTOs- reckoning of running allowance in case of running staff.

Instructions were issued vide Board's letter No. E(W)2008/PS5-1/38 dated 06.01.2011 linking revised entitlement of Passes/PTOs to Grade Pay.


